

IMPORTANT NOTICE – Terms and Conditions of Ticket Sales

This Ticket is sold for and on behalf of the organisation, venue, management and/or promoter (“The Seller”) responsible for the service or performance (“Event”) for which it is sold. The name of the Seller is usually shown on the front of the ticket and all complaints or claims are the responsibility of the Seller, not the ticketing agency, Ticket Direct, which is owned and operated by The Palmerston North Showgrounds Board Of Control Trading As Arena Manawatu

This ticket is subject to the following conditions and may be revoked by the issuer for breach of any of the specified conditions:

1. The Seller has the right to modify or cancel the Event without notice. The Event may be cancelled or stopped at any time due to an adversity beyond the Sellers control, without right to refund.
2. The Ticket Holder consents to and will permit the search and inspection of his or her person, clothing, bags or other possessions by any official, employee or agent of the proprietor of the venue and/or the organiser of the event both prior to and after the Ticket Holder’s entry to the venue.
3. The Ticket Holder is forbidden from taking any of the following articles into the venue:
 - a. Banners, placards, flags, or poles for displaying the same, or material for the construction or assembly of such articles.
 - b. Any article which is likely to injure or annoy other persons, including chemical substances which give off noxious fumes or smoke, glass bottles, alcoholic beverages, illegal drugs, weapons, loud hailers.
 - c. Goods intended for sale (if no written permit is held from the proprietor of the venue).
 - d. Any article which may hamper or impede the conduct of the event.
 - e. Recording devices and cameras.
4. The Ticket Holder will be required to leave the venue if he or she:-
 - a. Engages in which unreasonably interferes with the enjoyment of the event by the patrons, including fighting
 - b. Hampers or impedes the conduct of the event.
 - c. Breaches any by-laws or orders applicable to the venue.Any breach of conditions 3 a., 3 b., or 3 c., shall automatically revoke the Ticket Holder’s license to remain at the venue.
5. This Ticket is void if on-sold or traded at a premium or in conjunction with other goods or services, or used in advertising or as a competition prize, without prior written permission from TicketDirect. In the event of breach of this condition, the Ticket Holder will be denied admission / expelled and, on request, the Ticket will be delivered up to TicketDirect.
6. Latecomers may not be admitted until a suitable performance pause.

WARNING: Failure to comply with a direction to leave or stay away from the venue may render the Ticket Holder liable to arrest and prosecution for the offence of trespass under Sections 3 and 4 of the Trespass Act 1980 which is punishable on conviction by a fine of up to \$1000.00 or a term of imprisonment of up to three months.

NOTE: The Ticket Holder acknowledges that any information provided in connection with the issue and payment for this ticket may be retained and utilised by the issuer of the ticket or other parties authorised by the issuer. The Ticket Holder has the right to access and correct any information gathered and held by the issuer.
